

The SC4200c is a 2-channel controller for digital sensors. Refer to Figure 1.

The controller is configured and operated with a Mobile sensor management (MSM) software. The MSM software is accessible through a web application on a customer-supplied device with an internet browser that is connected to the internet. The controller connects to the MSM software with a cellular network (optional), WiFi network (optional) or through LAN connection. The MSM software is also referred as Cloud in this manual.


Note: The controller uses one ethernet port for Modbus TCP/IP based fieldbus communication with PLC/SCADA. Refer to Modbus TCP/IP on page 20.

The controller is available with optional expansion modules:

- 4–20 mA analog outputs—Such outputs are commonly used for analog signaling or to control
 other external devices
 - **Note:** Only one module can be connected.
- Profibus interface—Used to connect the controller to a Profibus DP (Decentralised Peripherals) network. PROFIBUS DP is used to operate sensors and actuators via a centralised controller in production (factory) automation applications.
- 4–20 mA analog inputs—The 4–20 mA input module lets the controller accept one external analog signal (0-20 mA or 4–20 mA).
 - **Note:** Only two input devices³ can be connected to the controller at the same time. Refer to the module documentation for additional information.

³ Input devices are mA input modules or digital sensors.

2.2.1 Claros Connector (optional)

Use the Claros Connector to connect SC200 or SC1000 Controllers that are not Claros enabled to the Claros cloud server.

Note: The enclosure of the Claros Connector is the same as the SC4200c controller enclosure, but the Claros Connector does not have the same functions as the SC4200c controller.



Section 3 Installation

A DANGER



Multiple hazards. Only qualified personnel must conduct the tasks described in this section of the document.

A bracket for panel mounting is available as an optional accessory. Refer to Replacement parts and accessories on page 43.

Used for variable diameter pipe mount installations.

3.1 Installation guidelines

ADANGER



Electrical shock hazard. Externally connected equipment must have an applicable country safety standard assessment.

NOTICE

Do not install the controller in an environment with a caustic atmosphere without a protective enclosure. A caustic atmosphere will cause damage to electronic circuitry and components.

NOTICE

Do not install the controller outdoors in an environment that receives direct sunlight or UV radiation or damage to the controller can occur. Install the optional UV protection screen with sunroof to prevent damage from UV exposure when installed outdoors in direct sunlight.

Note: Make sure that your IT department has approval for the installation and commissioning of the device. Administrator rights are not necessary. The email address "No-reply@hach.com" sends the setup email and "donotreply@hach.com" sends the system notifications that are necessary for the installation. Add the two email addresses to the safe senders list to make sure to receive mails from these senders. Hach does not send a request to confirm that the sender is not a robot.


- Install the controller in a location where the power disconnect device for the controller is easily operated.
- Attach the controller upright and level on a flat, vertical surface.
- As an alternative, attach the instrument to a panel, vertical pole or horizontal pole.
- Make sure that the device is in a location where there is sufficient clearance around it to make connections and to do maintenance tasks.
- Make sure that there is a minimum of 16 cm (6.30 in.) of clearance for the enclosure doors to
- Install the instrument in a location with minimum vibration.
- The optional holder for mobile phones is recommended for all installations.
- The optional sunroof or the optional UV protection screen with sunroof is recommended for all outdoor installations.
- Give protection to computers or other connected equipment that may not have equivalent environmental ratings based on the enclosure rating of the equipment.
- Obey specified ambient ratings on the internal side of panels for panel mount installations.
- Make sure that the maximum power rating is correct for the ambient temperature.

3.2 Mechanical installation

3.2.1 Attach the instrument to a wall


Figure 3 Wall mounting

Attach the controller upright and level on a flat, vertical surface. Make sure that the wall mounting is able to hold 4 times the weight of the equipment. Refer to the illustrated steps in Figure 3 and Product components on page 9 for the necessary mounting hardware.

3.2.2 Attach the instrument to a pole

Attach the controller upright to a pole or pipe (horizontal or vertical). Make sure that the pipe diameter is 19 to 65 mm (0.75 to 2.5 in.) Refer to the illustrated steps in Figure 4 and Product components on page 9 for the necessary mounting hardware.

Figure 4 Pole mounting




3.2.3 Install the instrument in a panel

A rectangular hole is necessary for panel installation. Use the supplied sealing gasket for panel mount as a template to cut the hole in the panel. Make sure to use the template in the up position to install the controller vertical. Refer to Figure 5.

Note: If using the bracket (optional) for panel mounting, push the controller through the hole in the panel and then slide the bracket over the controller on the back side of the panel. Use the four 15 mm pan head screws (supplied) to attach the bracket to the controller and secure the controller to the panel.

Figure 5 Panel mounting dimensions




3.3 Electrical installation

3.3.1 Electrical connectors and fittings

Figure 6 shows the electrical connectors and fittings on the instrument. To keep the environmental rating of the enclosure, make sure that there is a plug in the strain relief fittings that are not used and a connector cap on the unused connectors.

Note: The controller is supplied without strain relief fittings installed. The user must order the necessary strain reliefs.



3.3.1.1 Claros Connector—Electrical connectors and fittings

Figure 6 on page 13 shows the electrical connectors and fittings on the Claros Connector. To keep the environmental rating of the enclosure, make sure that there is a plug in the strain relief fittings that are not used and a connector cap on the unused connectors.

Note: The Claros Connector is supplied without strain relief fittings installed. The user must order the necessary strain reliefs.

3.3.2 Electrostatic discharge (ESD) considerations

NOTICE



Potential Instrument Damage. Delicate internal electronic components can be damaged by static electricity, resulting in degraded performance or eventual failure.

Refer to the steps in this procedure to prevent ESD damage to the instrument:

- Touch an earth-grounded metal surface such as the chassis of an instrument, a metal conduit or
 pipe to discharge static electricity from the body.
- Avoid excessive movement. Transport static-sensitive components in anti-static containers or packages.
- · Wear a wrist strap connected by a wire to earth ground.
- Work in a static-safe area with anti-static floor pads and work bench pads.



3.3.3.1 Open the controller cover

Open the controller cover to get access to the wiring connections. Refer to Figure 8.

Figure 8 Open the controller




3.3.3.2 Remove the high-voltage barrier

High-voltage wiring for the controller is located behind a high-voltage barrier in the controller enclosure. Do not remove the barrier while power is supplied to the controller. Make sure that the barrier is installed before power is supplied to the controller.

Remove the high-voltage barrier to get access to the high-voltage wiring. Refer to Figure 9.

ADANGER



Electrocution hazard. Protective Earth Ground (PE) connection is required.

ADANGER



Electrical shock and fire hazards. Make sure to identify the local disconnect clearly for the conduit installation.

AWARNING



Potential Electrocution Hazard. If this equipment is used outdoors or in potentially wet locations, a **Ground Fault Interrupt** device must be used for connecting the equipment to its mains power source.

AWARNING



Electrocution hazard. The local disconnection means must disconnect all the electrical current-carrying conductors. Mains connection must keep supply polarity. The separable plug is the disconnect means for cord connected equipment.

AWARNING



Electrical shock and fire hazards. Make sure that the user-supplied power cord and non-locking plug meet the applicable country code requirements.

AWARNING



Explosion hazard. This manual is only for installation of the unit in a non-hazardous location. For installation of the unit in hazardous locations, use only the instructions and approved control drawing provided in the hazardous location installation manual.

NOTICE

Install the device in a location and position that gives easy access to the disconnect device and its operation.

Supply power to the instrument with conduit or a power cable. Make sure that a circuit breaker with sufficient current capacity is installed in the power line. The circuit breaker size is based on the wire gauge used for installation.

For installation with conduit:

- Install a local disconnect for the instrument within 3 m (10 ft) of the instrument. Put a label on the
 disconnect that identifies it as the main disconnect device for the instrument.
- Rated for at least 90 °C (194 °F) and applicable to the installation environment
- For permanent connections use only solid wires. Use cable dimensions between 0.75 to 1.5 mm²
 (18 to 16 AWG). Flexible wires must have a crimped ferrule or pin type terminal on the end.
- · Connect equipment in accordance with local, state or national electrical codes.
- Connect the conduit through a conduit hub that holds the conduit securely and seals the enclosure when tightened.
- If metal conduit is used, make sure that the conduit hub is tightened so that the conduit hub connects the metal conduit to safety ground.

For installation with a power cable, make sure that the power cable is:

Make sure that the cable sheath goes through the inner side of the enclosure to keep the environmental rating of the enclosure.


The controller can be wired for line power by hard-wiring in conduit or wiring to a power cord. Regardless of the wire used, the connections are made at the same terminals.

The power cable plug is used to connect and disconnect power to the controller. For installation in conduit, the installed local disconnect is used to connect and disconnect power to the controller.

Refer to Figure 10 and Table 3 to connect conduit or a power cord. Insert each wire into the appropriate terminal until the insulation is seated against the connector with no bare wire exposed. Tug gently after insertion to make sure that there is a secure connection. If necessary, remove the connector from the PCBA for easier wiring of the terminals.

Note: Make sure that all of the cables stay below the cable limit line printed on the PCBA to prevent interferences with the high-voltage barrier. Refer to Figure 10.

3.3.4 Connect the high-voltage relays

ADANGER



Electrocution hazard. Always remove power to the instrument before making electrical connections.

AWARNING



Potential Electrocution Hazard. Power and relay terminals are designed for only single wire termination. Do not use more than one wire in each terminal.

Potential fire hazard. Do not daisy-chain the common relay connections or jumper wire from the mains power connection inside the instrument.

Fire hazard. Relay loads must be resistive. Always limit current to the relays with an external fuse or breaker. Obey the relay ratings in the Specifications section.

NOTICE



Make sure that the cable sheath goes through the inner side of the enclosure to keep the environmental rating of the enclosure.

The instrument has two non-powered relays, each with a single-pole change-over contact. Each relay changes state when the selected trigger condition for the relay occurs.

The relay terminals are located behind a high-voltage barrier in the controller enclosure. Do not remove the barrier while power is supplied to the relay terminals. Do not supply power to the relay terminals when the barrier is not installed.

Connect each relay to a control device or an alarm device as necessary. Refer to Figure 11 and Table 4 to connect the relays. Use the MSM software to configure the trigger condition for each relay.

Refer to Specifications on page 3 for the relay specifications. The relays are isolated from each other and the low-voltage input/output circuitry.

The largest gauge wire the power and relay plugs are rated for 1.5 mm² (16 AWG). The relay terminals accept 0.75 to 1.5 mm² (18 to 16 AWG) wire (as determined by load application). Use wire with an insulation rating of 300 VAC or higher. Insert each wire into the appropriate terminal until the insulation is seated against the connector with no bare wire exposed. Tug gently after insertion to make sure that there is a secure connection. If necessary, remove the connector from the PCBA for easier wiring of the terminals. Flexible wires must have a crimped ferrule or a pin type terminal on the end.

Note: Make sure that all of the cables stay below the cable limit line printed on the PCBA to prevent interferences with the high-voltage barrier.

The current to the relay contacts must be 5 A (resistive only load), 1250 VA 125 W (resistive only load) or less. Make sure to have a second switch available to remove power from the relays locally in case of an emergency or for maintenance.

Use the relays at high voltage (greater than 30 V-RMS and 42.2 V-PEAK or 60 VDC) only. The maximum switching voltage is 250 VAC Do not configure a combination of both high and low voltage.

Relay terminal connections to the mains circuit in permanent connection applications must have insulation rated for a minimum of 300 V, 90 °C (194 °F). Terminals connected to the mains circuit with a power cord connection must be double insulated and rated 300 V, 90 °C (194 °F) at both the inner and outer insulation levels.

Figure 11 Connect the relays



3.3.5 Install an expansion module

AWARNING

Expansion modules with analog outputs, analog inputs and Profibus communication are available for the controller. Refer to the documentation supplied with the module for additional information.

3.3.6 Modbus TCP/IP

Modbus TCP/IP is a standard for industrial communications. The Modbus TCP/IP protocol connects computers to measurement and control systems that use the TCP/IP protocol for data transmission. This type of data transmission is known as machine to machine (M2M) communication.

The controller is factory configured to be integrated directly in programmable logic controller (PLC) systems. PLC systems record and process the controller measured data. The data analysis and the procedures caused by the results are programmed in the PLC system.


Use the ethernet connector for TCP/IP based fieldbus communications to connect the controller to a PLC system. Refer to Figure 6 on page 13. When the controller is configured to share the LAN, the controller cannot connect to Modbuts TCP/IP. Make sure to disable the internet sharing setting and configure the ethernet port to adapt the Modbus TPC slave IP address to the PLC IP subnet

configuration. Refer to LAN connection on page 32. A Claros $^{\text{\tiny{M}}}$ connection is necessary to configure the Modbus TCP datagram.

A controller with mobile internet connection can connect to Modbus TCP/IP and share the internet connection through LAN. Refer to Figure 12.

Note: Make sure that the Modbus TCP master and one of the controllers are on the same IP sub-network.

3.4 Close the cover

A DANGER



Electrocution hazard. High voltage wiring for the controller is connected behind the high voltage barrier in the controller enclosure. The barrier must remain in place except when installing modules, or when a qualified installation technician is wiring for power, relays or analog and network cards.





The controller automatically finds connected sensors. The sensor status LED on the front panel flashes blue during the connection procedure. When the light stays on, the connection of the sensor is correct. Refer to User interface on page 24. Use the mobile application to configure and operate the connected sensors.

Retain the connector cap to seal the connector opening in case the sensor must be removed.









To change the Ethernet port configuration and use the port for network sharing, refer to Share the LAN on page 32.



Figure 18 Network sharing



5.3.2 Add a new user

Note: Only account administrators, HST¹⁷ and HSA¹⁸ can add more users.

- 1. Open the browser and log in to MSM.
- 2. Push to open the main menu.
- 3. Push and select **Users** to add a new user.
- 4. Push ADD.
- 5. Enter the first name, last name and email address of the new user.
- 6. Select the role of the new user.


5.3.3 Add a controller

- Install the mA output cards, relay cards and profibus cards in the controller. Refer to the controller user manual for installation instructions.
- Connect the sensors to the controller. Refer to the SC1500 and/or SC4200c controller user manual for installation instructions.
- 3. Supply power to the controller.
- 4. Connect the controller to the HACH Server.
- 5. To start the MSM application, open the browser on a Mobile device/PC and log in the account.
- Push Devices.
- 7. Push ADD CONTROLLER to add the controller.
- 8. Enter the serial number of the controller. Push Continue to confirm.
- 9. Wait 30 seconds, then refresh the browser. The controller will be **Online** on the device list. Refer to User interface and navigation—Mobile device/PC on page 25.
- 10. Make sure that the correct serial number and image of the controller are shown.
- 11. Select the controller on the device list to open the controller details page. The sensors and cards connected to the controller are shown. Refer to Figure 20.

- Make sure that the correct serial number, image and the correct measurement parameters of the device are shown.
 - After 30 seconds, the measurement values are updated for all devices. Refer to User interface and navigation—Mobile device/PC on page 25.

5.3.5 Configure a mA output card

Make sure that the controller is provisioned and connected to the HACH Server.

- 1. Select the mA output card from the controller details page.
- Push MENU to access the mA output card settings. The mA output card will be locked. Refer to Control function for devices on page 27.
- 3. Push System setup to show a list of channels.
- Select a channel and push Source.
- Select a sensor from the list. Push OK to confirm.
- 6. Select a parameter from the list. Push OK to confirm.

5.3.6 Configure a profibus card

Make sure that the controller is provisioned and connected to the HACH Server.

- 1. Select the profibus card from the controller details page.
- Push MENU to access the device settings. The device is locked. Refer to Control function for devices on page 27

- 3. Push Telegram.
- Push Add Sensor and select a sensor from the list. Push OK to confirm. The selected sensor shows.
- 5. Select the sensor and push ...
- Push Add Tag and select a tag from the list. Push OK to confirm. The selected tag shows.
- Push Save.

5.3.6.1 Change the sensor order

To change the position of the sensors in the list, do the steps that follow:

5.3.6.2 Delete a sensor

Section 6 Operation

Use the MSM software to interact with the connected measurement devices. Contact Hach Technical Support to get a Claros Mobile Sensor Management account for the first time.

6.1 Data download

Use the USB connection to download data from the controller. As an alternative, the data download procedure is also available through the user interface on the MSM software.

- Connect a USB flash drive to the controller. Refer to Connect a USB flash drive (optional) on page 38.
 - The controller automatically starts the download of all the local data to the USB flash drive: data log, event log and diagnostic data.
- 2. When the download is complete, remove the USB flash drive.
 - **Note:** The USB icon in the front panel flashes to show data transmission. Do not remove the USB flash drive until the light flashing stops.
- Close the USB cover

6.2 Firmware update

Make sure that the controller has the latest firmware. Use the USB connection to update the controller firmware. As an alternative, the firmware update procedure is also available through the user interface on the MSM software.

- 1. Visit www.hach.com and download the latest software version for your instrument.
- 2. Copy the files to a folder with the name Update in a USB flash drive.
- Connect a USB flash drive to the controller. Refer to Connect a USB flash drive (optional) on page 38.
 - The controller automatically finds if there is a software or firmware update in the USB flash drive Update folder and starts the update procedure.
- 4. When the update is complete, remove the USB flash drive.
 - **Note:** The USB icon in the front panel flashes to show data transmission. Do not remove the USB flash drive until the light flashing stops.
- Close the USB cover.

6.3 Connect a USB flash drive (optional)



If necessary for data download or firmware update, connect a USB flash drive to the front panel in the controller. Make sure that the USB flash drive is formatted with FAT32 and has a minimum of 350 Mb capacity. Refer to Figure 21. After the USB flash drive is removed, close the slot cover and tighten the cover screws. Tighten the cover screws with a maximum torque of 1.4 Nm (12.4 in./lb).

6.4 Set the SC sensors on hold

Use the instrument keypad to set connected SC sensors to hold mode during manual operation or maintenance tasks.

- Push the applicable channel button for 3 seconds. The sensor status LED changes to orange.
- 2. Push the channel button again to set the SC sensor back to operation.

6.5 Get access to Claros with Claros Connector

There are two procedures to get access to Claros with the Claros Connector.

6.5.1 Local user

To enter a Claros device menu as a local user, do the steps that follow:

- Push one of the two buttons on the Claros Connector.
 The two LEDs change to amber. All devices are locked for access through the cloud.
- 2. Complete the Claros device menu.
- Push one of the buttons again to unlock all devices.The two LEDs change to blue at the Claros Connector. All devices are unlocked.

6.5.2 Remote user

To enter a Claros device menu through the Claros cloud, do the steps that follow:


- 1. The two LEDs change to red.
- If an SC1000 Controller is used, a warning message shows the locked device at the SC1000 Controller display. All other devices are unlocked and a local user can get access.
- If an SC200 Controller is used, all devices are locked. Wait until the user has complete accessing the Claros cloud and the LEDs are blue again.

6.6 Install a software update—Mobile device/PC

If a software update for a device is available, a notification shows in the device list.

- 1. Select the device. The notification "Software update is available" shows.
- 2. Push > to show the information of the software version. Refer to Figure 22.
- 3. Push **Update** to start the software update.

7.1 Cleaning the controller
